## MORE INFORMATION

Thank you for considering leaving a bequest in your Will to Victorian Opera. It is a wonderful way to make a donation that will have an impact beyond your lifetime and is a powerful statement of your desire to support the work of the company.

Every bequest, regardless of size, will ensure that beautiful singing, glorious music, spiningling performances and divine opera, will continue to thrive. Following is information relating to articulating this in your Will. We recommend you discuss with your legal advisor who may assist you make the right choice.

### GENERAL information:

If you've decided to leave a bequest to Victorian Opera, thank you. In articulating this in your Will, the first step will be to specify whether it will be:

- An amount of money or a percentage of your estate that you would like to bequeath ('Pecuniary');
- The remainder of your estate, once family and friends have been provided for ('Residuary'). A Residuary Bequest means that you don't have to amend the gift in your Will if your financial situation changes;
- Other items such as shares or real estate, which will generate funds for the beneficiary ('Specific');

Your legal advisor can help you make the right choice.

The following is suggested wording for a clause that may be included in your Will to make a bequest to Victorian Opera:

*"I give to Victorian Opera Company Ltd ABN 56 116 549 798 or its successor, the a) residue of my estate [or] b) [specify %] of my estate [or] c) the sum of [insert specific dollar sum] to be used for its general purposes. I declare that the receipt by the secretary, treasurer or any other proper officer of Victorian Opera Company Limited will be a full discharge for my trustee who will not be bound to see its application."*

It is preferable that bequests to Victorian Opera are made for general purposes, however, if you choose to make a bequest for a stated purpose, we ask that you include the following provision in your Will:

*If at any time Victorian Opera determines that it is impossible or impracticable to carry out the stated purpose, then Victorian Opera may apply the bequest for such purpose or purposes as Victorian Opera determines most closely accords with the stated purpose.*
